

Potentiate Cash Prize Terms and Conditions AUTO SURVEY 2015/1

- 1. Information on how to enter and Prizes form part of these terms and conditions. Submission of an entry is deemed acceptance of these terms and conditions.
- 2. To enter, entrants must, during the Promotional Period (as defined below):
 - a. Visit http://autosurvey.potentiateglobal.com
 - b. Fully complete and submit the survey;
 - c. Confirm the requested details including the entrant's first and last name, contact address and state; and
 - d. Submit the fully completed entry form.
- 3. Subject to clause 4, entry is only open to Australian residents who are 16 years or over, as of the date of entry, and who have received an invitation to enter the Promotion from the Promoter as a result of purchasing and owning a vehicle from a participating vehicle manufacturer in the time period relevant to the survey.
- 4. If an entrant is under the age of 18 they must obtain prior consent from their parent or legal guardian to enter the Promotion and the parent or legal guardian may be required to verify the granting of consent and/or sign a release at the discretion of the Promoter.
